## NEW REPORTING REQUIREMENTS

Affordable Care Act: Additional Reporting Requirements

## DECEMBER 4, 2013

In an effort to set uniform data collection standards as required by Section 4302 of the Affordable Care Act (ACA), the Department of Health and Human Services (HHS) has provided guidance on the data standards for race, ethnicity, sex, primary language and disability status. Beginning with the December 7<sup>th</sup> release, the 'Additional Reporting Requirements' section in ProviderConnect will change to implement these recommendations.

Specifically, the questions for Race and Ethnicity have been switched to capture Ethnicity first, followed by Race (see below).

In addition, there are now three (3) questions pertaining to the consumer's Primary Language and a six (6) item set of questions to gauge disability.
