### APPROVAL OF ACCREDITING BODY

#### COUNCIL ON ACCREDITATION (COA)

#### **SEPTEMBER 15, 2016**

The Behavioral Health Administration's (BHA) proposed changes to the regulations governing behavioral health services will require many providers who are currently regulated to become accredited as a prerequisite to licensure. Health General Article of the Annotated Code of Maryland, 19-2302 authorizes the Secretary of the Department of Health and Mental Hygiene to approve accrediting bodies who seek to ensure that Maryland community behavioral health care programs adhere to professional and legal standards.

The Council on Accreditation was previously approved as an accrediting body for Respite Services only. A reference grid providing an **updated** crosswalk from the regulations program and service descriptions to the corresponding COA set of standards will be published in the coming weeks to BHA's Accreditation Webpage (<u>http://bha.dhmh.maryland.gov/Pages/Accreditation-Information.aspx</u>) and is contained below.

### BH Program Descriptions/COA reference grid August 12, 2016

All programs accredited through the Council on Accreditation (COA) must meet all applicable standards located in the "Administration and Management Standards" section and the "Service Delivery Administration Standards" section, in addition to the applicable chapter(s) of the "Service Standards" section.

The chart below is meant to be a one-page reference guide identifying the "Service Standards" that correspond to each of the program descriptions identified in the Community-Based Behavioral Health Programs and Services regulations (COMAR 10.63).
