### RESIDENTIAL SUD FOR ADULTS OVERVIEW OF PROVIDER ALERTS

#### JUNE 1, 2017

This provider alert serves to remind providers of recent alerts published by Beacon Health Options that are essential to enrolling with Maryland Medicaid as a Provider Type 54 for Residential Substance Use Disorder (SUD) Services (ASAM level 3.3, 3.5, 3.7, and/or 3.7WM) for Adults.

Currently licensed Residential SUD providers should plan to attend the Provider interest meeting scheduled for Monday June 5<sup>th</sup>, 2017 at BHA (see reminder #4 below). Providers will have the opportunity to ask questions to prepare for implementation on July 1, 2017.
